Auditor Comments:

- 1) AFOX Corporation, the professional graphics card and motherboard manufacturer with the reputed brand named "AFOX" presents reliable products for the key players from America/Europe/Middle East/South East Asia in PC industry. They said they created the total value of 90 million dollars of exporting PC components and this number still growing.
- 2) Factory is busy working and 3 production lines were running. 2 Packing lines were packing the graphics cards. Warehouse on 1st floor is full of goods ready for shipment.
- 3) Due to technical confidential issues, the factory doesn't allow us to take photos of production process, especially for the equipments.
- 4) The factory refused to provide internal document for audit view.
- 5) No found working instrument on the production line.
- 6) The APP can not running to check the working function due to Chinese goverment limited.
- 7) The factory can not provide QC document for audit view.
- 8) During visiting, inspector found there are about 8 employees in the office of the factory, but factory claimed they have 180 office people including 30 sales beside their factory but we can not visit.
