Ouote

Before placing an order, please ask for sales in Keyee Microwave about price, stock, and delivery information. When placing an order, clear info such as Quotation Number, E-Mail, or company info and contact person. All prices are EXW Keyee Microwave. Pricing does not include any type of additional charges such as shipping and handling. Quotations validity is 60 days from date of quote. All pricing is current at time of quotation; But if any change of continual product improvement, Keyee Microwave have right to change specifications and prices without notice.

Minimum Order

All orders less than ten thousand dollars (\$10,000.00) net will accept 100% advance payment unless mutually agreed upon between the Buyer and Keyee Microwave. A more than ten thousand dollar(\$10,000.00) net minimum order is required for the first order from new customers requesting 60% down payment and 40% before shipment release.

Terms of Payment

Unless otherwise agreed by Keyee Microwave in writing, payment will be accepted by wire transfer in advanceonce place an order. Upon receipt of purchase order, Keyee Microwave will provide a Pro Forma Invoice. Paypal and Western Union are also accepted if order less than \$200.00. Keyee Microwave reserves the right to charge a processing or bank handling fee for any non-credit card international orders.

Shipments Risk of Loss

Unless otherwise agreed by Keyee Microwave in writing, all sales are made EXW Keyee Microwave's factory. Risk of loss shall pass to Buyer when the goods are arranged for shipment or picked up by buyer's logistics. Therefore any damage incurred during shipment must be settled between the Buyer and the Carrier. The most appropriate means of transportation will be chosen by Keyee Microwave unless otherwise specified on the Buyer's P.O.

Warrantv

Keyee Microwave warrants each product it manufactures to be free from defect in workmanship and materials under normal use and service for one year from date of shipment. All Warranty returns must be authorized by Keyee Microwave and given a Return Materials Authorization Number (RMA#) prior to their return. Arrange with Keyee Microwave to have any product found defective under normal use during this one year period to be returned to the factory where it will be repaired or replaced.
